- Substantiation of Need for Assigned and Unassigned Ending fund Balances in Excess of Minimum Recommended Reserves Have \$1.2 million in reserves that would be for bus replacement, roof replacement, grounds replacement, paint the school, A/C for the multipurpose room, well repair, and keeping 10% of reserves to use for undesignated purposes.
